- b) Minimum 5 years experience (Airport/Airlines/Regulated Agent) of Indian Civil Aviation Security in operations and administration.
- c) Appropriate knowledge of BCAS and DGCA Regulations
- d) Knowledge of Information Technology

#### **(B) FOR CERTIFIED SECURITY SCREENER :-**

- e) Graduate or equivalent (minimum 3 years duration) from any recognized University/Institution.
- f) Essential – (i) Posses valid BCAS Basic AVSEC (13 days) Certificate; (ii) Ability to read/speak English, Hindi and conversant with local language. Knowledge of computer operation.
- g) Preferable – (i) BCAS Certified screener (valid certification); (ii) BCAS Certified In-Line Screener (Valid Certification); (iii) A copy of Indian Passport issued within last 5 years.

**Experience ::** Minimum 3 year experience as certified security screener.

#### **(C) FOR MULTITASKERS**

Minimum class 10<sup>th</sup>/ Matriculation qualified with ability to speak in Hindi, English and conversant with local language.

#### **Other Qualifications (Desirable):**

- (b). Candidates having Baggage Handling Training Course/ Certificate from National Skill Development Corporation (NSDC).

## 7. HOW TO APPLY:

The very first step for filling the Application Form. Each candidate has to register himself/herself on the link given on the website of AAICLAS under career options. For registration, each candidate has to keep handy his/her e.mail ID and valid mobile number. PLEASE MAKE NOTE OF IT THAT ALL COMMUNICATIONS BY AAICLAS SHALL ONLY BE MADE ON THE REGISTERED E.MAIL ID OF THE CANDIDATES AND NOT BY POST. So keep remember the e.mail ID, Mobile Number and Password used at the time of registration.

7.1 Go to the AAICLAS Website [www.aaiclas.aero](http://www.aaiclas.aero) then go to the career option. View the detailed advertisement. In case you meet the eligibility, press the given link under carrier options and register yourself as guided above.

- 7.2 After registration, start filling the application form for the position. While applying online, candidate should keep the scanned copy of their recent passport size color photograph & signature (in format \*.jpg or \*.jpeg file only) maximum size 20 KB each. After filling all column & attaching photo and signatures, the form will redirect you to make payment option. Press that button and deposit application fee online. Please make note of the payment deposited acknowledgement number and date for filling the same in application form. On submission of requisite fee, your filled-in form shall automatically again be opened and after submission of the fee detail etc., press submit to submit the button.
- 7.3 Please ensure that in case at any stage it be found that any wrong/false information is given by the candidate, the candidature of the said candidate be treated as cancelled without assigning any reason whatsoever. In case the wrong/false information comes to the notice of the management at a later stage, the engagement be treated as cancelled and necessary recovery be made in addition to action, as per rules.
- 7.4 **Valid E-Mail ID:** The E-Mail ID entered in the online application form should remain active until the engagement process is completed. No change under any circumstances in the e-mail id will be allowed once entered. All correspondence regarding this recruitment shall be made on registered e-mail id only.
- 7.5 Candidates who fulfil the eligibility criteria would be required to appear for Walk-in-interaction on the above date, time and venue. Further, they will bring all the original certificates/mark sheets/experience certificate/professional qualification certificates/training certificates/Aadhar Card/ PAN Card/ Category Certificate (if applicable) / other documents (if any) etc. along with one set of self-attested copy of each document. The self-attested copy of each documents to be submitted with AAICLAS office at the time of interaction.

## **8. GENERAL**

- 8.1 Candidates meeting the eligibility criteria **as on 30.11.2021**, are required to appear for **WALK-IN-INTERVIEWS** with the print out of duly filled in Application Form (available on the Company website [www.aaiclas.aero](http://www.aaiclas.aero)) along with all Original Certificates/Testimonials/PAN Card/Aadhar Card etc. in support of Date of Birth, Educational Qualifications/ Experience Certificates, Caste/Category Certificate (for SC/ST/OBC/EWS/PWD/EXSM Candidates), Experience Certificate if any. Candidates would also to be required to furnish self-attested copies of all the certificates/testimonials as mentioned above along with the application form. Please note that no original document is to be submitted with the Application Form. However, Candidates are required to bring all Original Certificates for verification purpose only.

- 8.2 Candidates belonging to OBC category should submit the certificate in the prescribed format including the "Non-Creamy layer clause" issued by the Competent Authority for employment under Government of India and should be as per the Central list of OBC's published by the Government of India. Please also note that the validity of the "Non-Creamy layer should not be older than Six (6) months from the date of the eligibility i.e. 30.11.2021 (Format of OBC certificate is attached as Annexure 'B').
- 8.3 A recent (not more than 3 months old) coloured passport size photograph of the full face (front view) should be pasted neatly in the space provided in the Application Form.
- 8.4 Candidates working in Government/Semi-Government/Public Sector Undertakings or autonomous bodies must walk-in with the completed Application Form routed through proper channel or along with "No Objection Certificate" from their present employer.

## **9. GENERAL CONDITIONS:**

- 9.1 The short-listed candidates will be considered for engagement on a Fixed Term Contract basis (FTC) initially for a period of three year subject to their Medical Fitness, prescribed for the position. The period of one year (for all positions) will be treated as probation period and on successful completion of probation period, the period of engagement will be considered for extension at the sole discretion of the Management of AAICLAS. Selected candidates will have to join the station of engagement, then only the engagement will come into force.
- 9.2 Selected Candidates will have to bear the cost of the Pre-Engagement Medical Examination(s).
- 9.3 For the selection process, no reimbursement w.r.t. TA/DA shall be made in this regard.
- 9.4 Period of Contract: Fixed Term Contract (FTC) for a period of three years further extendable on need of the company and looking into the performance of the candidates.
- (a) The FTC will be renewable at the sole discretion of the management of AAICLAS only subject to satisfactory performance.

- (b) The Contract could be terminated earlier at the discretion of the Management during the validity of the contract, and/or in the event of unsatisfactory performance. The job is transferable to any station.
- 9.5 Selected Candidates will be required to deposit an amount of Rs.1,00,000.- (Rs. One lakh only) as interest free Security, for the positions of Manager, Executive, Supervisor and Certified Screeners. However, for Multitaskers the interest free security deposit amount shall be Rs.25,000/-. This 'Security Deposit' shall be kept with AAICLAS for a period of 3 year and each selected candidate has to sign a Bond to serve the company for a minimum period of 3 years. On completion of successful contract engagement of three years, the 'Security Deposit' will be refunded to the candidates. In case of failure of Contract Conditions or leaving the Company without notice and/or their engagement is terminated due to reasons attributable to them, the 'Security Deposit' will not be released and be forfeited.
- 9.6 The applicant must ensure that they fulfil all the eligibility criteria, **as on 30/11/2021**, and that the particulars furnished by him/her in the application are correct in all respects.
