- 2. Firms are requested to visit the site before submitting their offer for proper understanding of the scope of work.
- 3. Quotations submitted in any other format will be rejected.

4. Rate should be quoted for "Annual Comprehensive maintenance contract (ACMC) for weighing scales (Make- M/s. Microtech Weighing Inc.) at AAICLAS Cargo Terminal, LGBI Airport,



Guwahati for a period of 02 year from the date of acceptance of award. (as per attached schedule Annexure-II)" (including all taxes like GST etc. and any other cost associated).

5. Scope of work includes following:

- (i) Annual Comprehensive Maintenance of weighing scales (Make- M/s. Microtech Weighing Inc.) including repair, servicing and replacement of all spare parts.
- (ii) Breakdown maintenance visits.
- iii) Monthly preventive maintenance visit.
- (iv) Arranging yearly stampings 'weight and measures from Legal Meteorological Department Govt. of Assam' including paying the stamping fee as per actual site requirements of weighing scale; installed at AAICLAS Air Cargo Complex (DACT-1, DACT-2 & International Air Cargo Terminal), LGBI Airport, Guwahati.
- 6. The quotations should be submitted on two envelope basis, the main sealed Master envelope (super scribed as Annual Comprehensive maintenance contract (ACMC) for weighing scales at AAICLAS Cargo Terminal, LGBI Airport, Guwahati.) should contain two sealed envelopes cover no: A and cover no: B as described below: -
- 6.1 Cover No. A: super scribed as <u>Technical Bid</u> must contain:
 - 6.1.1 Unconditional acceptance of AAICLAS terms and conditions (Annexure- I) duly signed (with seal) by bidder.
 - 6.1.2 Proof of PAN No. & GST registration proof shall be attached.
 - 6.1.3 Shop registration certificate or MSME certificate.
 - 6.1.4 Address Proof of having a registered office/branch at Guwahati on the date of call of NIQ.
 - 6.1.5 Repair/Maintenance Licence Issued by the Controller of Legal Metrology, Govt. Of Assam.
 - 6.1.6 Undertaking regarding debarment/ Black Listing (Annexure-II).
 - 6.1.7 Duly signed copy of NIQ (All pages).

The firm should submit self-certified documents by their authorized signatory, in support of their eligibility in their offer, failing which the offer may be rejected.



6.2 Cover No. B: Super scribed as Price Bid must contain:-

- 6.2.1 Rate & taxes etc. for Annual Comprehensive maintenance contract (ACMC) for weighing scales (Make- M/s. Microtech Weighing Inc.) at AAICLAS Cargo Terminal, LGBI Airport, Guwahati for a period of 02 year from the date of acceptance of award being quoted as per Annexure-III duly filled and signed by the bidder with a seal.
- 6.2.2 Price quoted in any other format will be **rejected.**
- 6.2.3 L1 Bidder may be decided on the basis of total quoted price (including GST)

7. Technical bid will be opened on 22.03.2024 at 1530 IST followed by Price bid opening date of which will be intimated later in presence of interested bidder or their authorized representatives. AAICLAS will not be responsible for delay in submission of quotations sent by post.

8. The price quoted in **Annexure-III** should be inclusive of packing and freight charges, toll charges, including of GST and any other cost associated with transportation. No extra payment will be made other than the quoted amount. The lowest bidder (L-1) shall be considered on the basis of total quoted amount (including of GST) not on the basis of quoted value for individual items.

9. The validity of quotation should be for a minimum period of 90 days. The period of contract will be for 02 year from the date of acceptance of award.

10. Incomplete and ambiguous quotations will be rejected.

11. Successful bidder has to submit agreement on non-judicial stamp paper of value Rs. 500/- (Rupees Five Hundred only) within 10 days of acceptance of work order.

12. Successful bidder has to submit security deposit of 10% of Work Order Contract amount within 7 days otherwise AAICLAS will deduct the same from the running Bills.



13. The vendor should ensure that higher quality of the material used for maintenance of weighing scale.

14 **Payment terms**:

- i) Payment shall be carried out on quarterly basis on production of Bills/ Invoices by the firm.
- ii) The payment will be made through the e-Payment system. As such the following information may please be provided in the quotation:
 - a) Name of the Bank and branch to which payment is to be credited.
 - b) IFSC code of branch for e-payment.
 - c) Account number allotted by branch to the supplier.
 - d) Bill should be raised in the name of Station In-charge, AAICLAS, LGBI Airport, Guwahati.

15. Other Conditions:

01. At any stage, if the firm continuously fails to provide the satisfactory service, AAICLAS shall terminate the contract without further notice. Decision of AAICLAS is final & binding in this regard.

02. All the rules and regulations / code of conduct shall be followed which has been laid down by AAICLAS from time to time.

03. The AAICLAS shall allow the contractor or agents or representatives or employees to enter into the said premises for the purpose of execution of the said job. Arrangement of Airport Entry Pass is the responsibility of the Firm. However, AAICLAS will recommend the same. The manpower deployed by the firm to the job, should have valid photo ID Card with Address Proof. If any expenses occur, the firm shall liable to pay the same.

04. The AAICLAS will not be responsible for any injury sustained by contractor's workers during performance of their duties and also for any damages or compensation due to any dispute between the firm and their workers.



05. For any loss or damage due to faulty or poor work, the contractor shall be liable for compensation to the extent of damage done. AAICLAS has the full authority to get the damage rectified on contractor's **risk and cost** and take over the system without any reference to the contractor. However, the decision of the Engineer in charge in this regard shall be final and binding.

06. After completion of the work, the firm should clean the premises at their own cost.

16. **Penalty-** If service or replacement of part if any is not provided by vendor within 24 hours (One days), then **the vendor shall be penalized at Rs. 500 per day per complain**.

14. EXTENSION OF CONTRACT

AAICLAS reserves the right to give Extension order of one more year with the same terms & conditions after completion of contract period which may include or exclude quoted rates of similar type with corresponding change in total cost.

15. AAICLAS reserves the right to accept/reject any quotation without assigning any reason.
