AAICLAS is a professionally driven and responsive service enterprise with a vision to emerge as the largest Integrated Cargo logistics and ground handling operator in the country.

To drive this business, it requires **Assistant Manager (Security)** on Fixed Term Basis <u>for a period</u> of three years on PAN India basis, as per the details given below:-

## Reservations wherever allowed, are applicable as per rules.

The candidates can be transferred to any location with in India due to operational or administrative requirements at the discretion of AAICLAS Management, which shall be binding.

"The Candidates who are not willing to serve on All India Basis need not to apply."

All the above number of positions may be changed with the sole discretion of AAICLAS Management. The engagement shall be made in phased manner as per requirement. AAICLAS Management reserves the right for change/cancellation of part or full advertisement/number of positions/venue/procedure/date /time of interaction etc. In case of requirement of manpower at any other new stations, the selected/panel candidates may be allowed to join at the respective locations, as per the requirement of the company. The decision of the AAICLAS Management shall be final and binding under all circumstances. AAICLAS reserves the right to increase or decrease or scrap these positions/advertisements in part or full, depending upon the present/future requirements or due to any other administrative issue.

The eligibility criteria for all posts as on 01.07.2023 shall be as follows: -

### 1. Assistant Manager (Security):

- (a) **Essential Qualification:** Graduation of 3 years duration from any recognized Board /University/ Institution
- (b) (i) Possess valid BCAS Basic AVSEC (13days) certificate, (ii) Possess valid BCAS Screener Certification (Standalone or ILHBS), (iii) Valid Dangerous Goods Certification will be preferable. (iv) Ability to read/ speak English, Hindi and / or conversant with local language.
- (c) **Desirable:** Leadership quality and presentation skills.
- (d) **Age Limit:** Age as on 01.07.2023 should not be more than 50 years.
- (e) **Experience:** Minimum 5 years of Experience with any Airport/ Airlines / Airport Operator and with atleast 3 years of experience with AAICLAS.
- (f) **Job profile:** Imparting AVSEC Training etc., in addition to other security / safety related functions and assignments, as per the need of the company.

#### **GENERAL CONDITIONS**

#### (i) Nationality / Citizenship

Candidate must be a citizen of India.

Please note that the eligibility criteria specified herein are the basic criteria for applying the post. Candidates must necessarily produce the relevant documents pertaining to nationality, age, educational qualifications, preferential qualifications, experience etc. in original along with a photocopy thereof in support of their identity and eligibility at the joining.

#### (ii) <u>Tenure</u>

The short-listed candidates will be considered for engagement on a Fixed Term Contract basis (FTC) initially for a period of three years (further extendable on need/performance basis). The period of one year (for all positions) will be treated as probation period and on successful completion of probation period, the period of engagement will be considered for extension at the sole discretion of the Management of AAICLAS (on need & performance basis). Selected candidates will have to join the station of engagement, then only the engagement will come into force.

#### 2. Upper age limit as on 01.07.2023

Age relaxation of 5 years to candidates belonging to Scheduled Caste/Scheduled Tribe and age relation of 3 years to OBC (Non-Creamy Layer) shall be considered. All relaxations shall be subject to submission of valid certificate issued by appropriate government authority.

The date of birth as recorded in the Matriculation/Secondary Examination certificates will only be accepted. No subsequent requests for change in date of birth will be entertained.

#### 3. Pay and Allowances

a) Initially, the selected candidates will be offered the post of Assistant Manager Security (Trainee) and the remuneration for the Position will be as follows:-

**b)** Selected candidates will be nominated for the Instructor/ Auditor Certification. After the successful passing of the requisite BCAS certified Instructor/ Auditor certification, the designation of Assistant Manager Security (Trainee) will be promoted to Assistant Manager Security (Instructor)/ Assistant Manager Security (Auditor) and the following remunerations will be paid:-

#### For Assistant Manager Security (Instructor/ Auditor):

Only during the first attempt, all the instructor certification trainings will be arranged by AAICLAS at its own expenses. All arrangements e.g. travelling etc. for undergoing training shall also be made by AAICLAS, as per the entitlement of the candidate/ personnel. In case during first attempt candidate not qualify the above examination, than for the second attempt all the training costs including the TA/DA & accommodation charges etc. shall be borne by the candidate himself/herself and only the nomination shall be made by the company that too in case the candidate be ready for the same otherwise his/ her nomination for Assistant Manager (Security) will stand cancelled and shall be re-designated as Security Screener.

Also, if the candidate fails during the second attempt for the above course the position of Assistant Manager Security (Trainee) will stand cancelled and shall be re- designated as Security Screener.

For candidates those who are already drawing higher pay than the remuneration, the pay protection may be considered with 3% additional increment, additional amount (Difference) of above emoluments shall be paid as Special Pay.

<u>In addition to above:</u> PF Contribution shall be equivalent to the basic of Rs.15000/-. TA/DA/Lodging & Boarding (if be deputed on tour) shall be equivalent to AC II tier rail fare.Leaves: Privilege Leave – 18 in a year + 12 Half Pay Leave (sick leave) + 9 CL + 2 RH.TA/DA will be provided to the selected candidate for journey period to the place of posting.

**Medical Insurance:** A maximum of Rs.10, 000/- per annum shall be reimbursed on account of purchase of Medical Insurance by the personnel for self & dependent family members, on production of duly certified tax invoice/receipt thereof.

**Gratuity**, as per Gratuity Act, as applicable.

At the time of reporting, selected candidates have to provide a surety bond of Rs.1,00,000/-, on non-judicial stamp paper of Rs.100/- (duly attested by Oath Commissioner) as an Oath regarding security deposit, that in case of non-completion of full period of training/stipend/engagement of contract i.e. 3 years he/she shall refund Rs.1,00,000/- to AAICLAS and in case of his failure to do so, AAICLAS may recover the same from Sureties (who shall sign on the surety bond) and in case of litigations, the jurisdiction shall only be Delhi/New Delhi. In case of litigations, the security deposit shall be recovered with cost & penalty, as per rules.

#### c) Selection Procedure

#### 4. <u>Important Instructions</u>

- 4.1 Shortlisted Candidates meeting the eligibility criteria as on 01.07.2023, will be called for personal interaction.
- 4.2 PLEASE MAKE NOTE OF IT THAT ALL COMMUNCIATIONS BY AAICLAS SHALL ONLY & ONLY BE MADE ON THE REGISTERED e-mail ID OF THE CANDIDATES AND NOT BY POST. So, keep checking the email ID to be informed to AAICLAS for the purpose.

- 4.4 Please ensure that in case at any stage it be found that any wrong/false information is given by the candidate, the candidature of the said candidate be treated as cancelled without assigning any reason whatsoever. In case the wrong/false information comes to the notice of the management at a later stage, the engagement be treated as cancelled and necessary recovery be made in addition to action, as per rules.

- 4.5 Valid E-Mail ID: The E-Mail ID entered in the application form should remain active until the engagement process is completed. No change under any circumstances in the e-mail id will be allowed once entered. All correspondence regarding this recruitment shall be made on registered e-mail id only.
- 4.6 In case of any change or amendment or updation or deletion (in part or full) either with regard to the number of position; cadre; remuneration; criteria; eligibility etc., (either prior to or post publication) the same shall only be updated/uploaded on the official website of AAICLAS www.aaiclas.aero.
- 4.7 Candidates who fulfil the eligibility criteria would be required to appear for Walk-in interaction on the date, time and venue/mode as is given above or to be informed through call letter on the registered e mail ID of eligible candidate. Further, they will bring all the original certificates/mark sheets/experience certificate/professional qualification certificates/ training certificates/Aadhar Card/PAN Card/ Category Certificate (if applicable) / other documents (if any) etc. along with one set of self-attested copy of each document, if be selected. - 4.8 The short-listed candidates will be considered for engagement on a Fixed Term Contract basis (FTC) initially for a period of three years. The period of one year (for all positions) will be treated as probation period and on successful completion of probation period, the period of engagement will be considered for extension and/or fresh contract at the sole discretion of the Management of AAICLAS. Selected candidates will have to join the station of engagement, then only the engagement will come into force.
- 4.9 For the selection process, no TA/DA or reimbursement etc. shall be made by AAICLAS.
- 4.10 Period of Contract: Fixed Term Contract (FTC) for a period of three years further extendable purely on need of the company as well as performance of the candidates.
- (a) The FTC will be renewable/fresh contract, as the case be, will only be at the sole discretion of the management of AAICLAS only subject to satisfactory performance.
- (b) The Contract could be terminated earlier at the discretion of the Management during the validity of the contract, and/or in the event of unsatisfactory performance. The job is transferable to any station.
- 4.11 The applicant must ensure that they fulfil all the eligibility criteria, as on 01.07.2023 and that the particulars furnished by him/her in the application are correct in all respects. At any stage of the Selection Process, if the particulars furnished by the applicants in the application or testimonials attached/providedare found to be incorrect / false, or not meeting with the eligibility criteria prescribed for the position, the candidature is liable to be rejected and, if engaged, engagement will be terminated, without giving any notice or reasons therefor.

- 4.12 Any canvassing by or on behalf of the candidate or bringing political or other outside influence, with regard to their engagement / selection shall be considered as DISQUALIFICATION.
- 4.13 The decision of AAICLAS Management regarding the eligibility criteria, acceptance or rejection of applications, mode of selection to any of the above position(s) etc. shall be final and binding on all the candidates. Merely fulfilling the minimum qualifications, experience and job requirement will not vest any right on candidates for being called for tests/selection process etc. The Management of AAICLAS may evolve its own procedure for short-listing/selection of candidates. No correspondence will be entertained from candidates found ineligible or not called for test/selection process etc.
- 4.14 This particular contract is initially for a period of 3 years and in case of closure of any AAICLAS station (due to any reason), the individual has to complete his/hercontract at other station, as per the need of the company, which shall be binding on all candidates/selectees.
- 4.15 AAICLAS reserves the right to modify/ alter/ restrict/ enlarge/ cancel the engagement/ selections process, in part or full, if need so arises, without issuingany further notice or assigning any reason whatsoever. The decision of the AAICLAS Management will be final and no appeal will be entertained in this regard.
